Standard for All Matches:

- The GSVO R1/R2, scorekeeper, and libero tracker must arrive 30 minutes prior to match start and 20 minutes for GSVO line judges.
- If teams are from different leagues, then the format for the host school or tournament guidelines will apply.
- Home team shall provide the 2 line judges, scorekeeper, libero tracker, and timer if not assigned by GSVO.
- Per WIAA mandate, the visiting team always gets the first on-court warm-up time unless otherwise noted.
- Hitting or serving the ball into the opponent's court is not allowed during the shared court time.
- Please ensure that all people serving as lines judges, whether students or adults, are in proper footwear.
- If there is a discrepancy between the format sheet and what the school asks you to do, follow the school's request, and then contact the Assignor after the match.
- Teams are not allowed to warm up on the sidelines or end lines while waiting for their court time but may utilize another court.
- ALL leagues have opted to not switch sides for the 2025 fall season. Line judges will switch sides between sets unless R1 decides
 otherwise per Rule 5-4-1g.
